

## ACTOR CONTRACT AND CANCELLATION POLICY

1. Our classes are for 18 and over only.
2. By submitting payment and entering your name, address, and phone number, you have entered into a contract with Actor's Artistry to provide you with talent training services.
3. You acknowledge that workshops/classes/showcases/intensives are NOT an audition, and that any scene you bring in to perform is from a piece that has already aired or been publicly released, and in no way a means of auditioning or attempting to procure employment . **DISCLAIMER: THIS IS NOT AN AUDITION OR REFERRAL FOR EMPLOYMENT OR FOR OBTAINING A TALENT AGENT OR TALENT MANAGEMENT REPRESENTATION.** I understand that the presence of an industry guest or talent agent/manager is absolutely NOT any kind of advertising or suggestion or indication whatsoever that Actor's Artistry (and its classes/workshop/showcases/seminars/intensives) is in any way a service for procuring (or attempting to procure or offering or promising) an audition or employment or artist engagement or referral of any kind; nor is it an audition or referral of any kind for obtaining representation with a talent agent or talent manager. I further understand that the intent of this class is solely educational. I also acknowledge that I release Actor's Artistry and its guests of all liability if I have chosen to mislead our staff, or ignore our rules regarding scene selection and any other policies we have set in place. I agree that while I am at an Actor's Artistry class/workshop/showcase/seminar/intensive I will treat it and any questions asked of guests solely in an educational manner.
4. All fees for services are due at the time of registration and are clearly marked on each class/workshop/showcase/seminar page of ActorsArtistry.com and in all email advertising.
5. Multiple Agent/Manager classes/showcases/seminars/intensives: Due to unforeseen circumstances, if a guest cannot attend we reserve the right to try and replace them with another guest, we will update the website with current information if this happens. Circumstances can happen and sometimes guests must be replaced the day of the event. If a guest cancels last minute and we do not have time to replace them, you will receive a prorated store credit good for 6 months from issue date. We do send out confirmation and reminder emails to our guests as extra steps to ensure they will be there!
6. You acknowledge that all information is current as of when the industry professional is booked for the event, and that Actor's Artistry are not responsible for industry professionals changing offices/projects.
7. This contract is valid from the date executed and up until (and including) the date of the showcase/workshop/class/seminar purchased, unless canceled by the actor within this time. (please see our 10 day cancellation policy below in section 9 of this agreement).

8. Classes and events take place between various times during the week usually on evenings and weekends and last between 2-3 hours in duration. The referred to industry guest may critique each actor's performance, answer questions, or provide feedback on the actors strengths and weaknesses. The Instructor or agent/manager will speak to the actors attending, answering questions at the start or end of the educational class/workshop/showcase/seminar in regard to how their office operates, insights into the industry, how to be a successful actor, acting techniques, etc. Each actor will perform a scene or monologue (excluding those from television, film or commercial that have not already aired or previously been cast) in front of other actors attending and the Instructor or agent/manager. The Instructor or

agent/manager may choose to provide a numbered score/written evaluation critique and/or verbal feedback on the actor's performance/scene work. Other actors will view these performances as it is an excellent learning tool. In addition to the group classroom Question & Answer portion, actors will receive a group classroom 30- to 45-minute informational portion (by our staff or other guest), live or a video, that is full of practical up-to-date information on acting, audition techniques, the industry, representation, marketing yourself, headshots/resumes, networking, social media, unions, and much more. Actors also receive additional in-depth educational feedback and critiques with our staff at our included free feedback classes when available on the calendar before or after their class/showcase/workshop/seminar and in the time frame specified on the website. Please read further the labor law below.

### **Your Right to Cancel**

You may cancel this contract and obtain a full refund, without any penalty or obligation, if notice of cancellation is given, in writing, within 10 business days from the above date or the the date on which you commence utilizing the services under the contract, whichever is longer. For purposes of this section, business days are Monday through Friday. To cancel this contract, mail or send by email a signed and

dated copy of the following cancellation notice or any other written notice of cancellation to Actor's Artistry at 1825 N. Vermont #292534, Los Angeles, CA 90029 or [ActorsArtistry@gmail.com](mailto:ActorsArtistry@gmail.com) , 323-524-8360, ActorsArtistry.com. NOT LATER THAN MIDNIGHT OF 10 days after said receipt, or 10 days after the date of the beginning of utilization of service. As this contract is executed in part or in whole through the internet, you may cancel this contract by sending the notification to ActorsArtistry@gmail.com.

You may NOT obtain a refund after the 10-day cancellation period described above (in paragraph 5 of section 1703 of Labor Code 4.5) has expired.
